Submission from The Lilydale & District Historical Society Inc.

The Lilydale & District Historical Society supports the extent of registration providing the present quarry is filled with the surrounding overburden built up over 15 or more years for this very purpose. We anticipate that by including the quarry as part of the registration Heritage Victoria will require detailed documentation of the works done at each stage. We believe a small section of the quarry will be retained to demonstrate how the quarry operated throughout the years.

Our society worked closely with both Sibelco and the Shire of Yarra ranges in developing the application for a heritage overlay on the site and we are pleased these areas have been retained in this application.

As someone who has spent many years studying both David Mitchell and his daughter Dame Nellie Melba, I believe the businessman who was so involved with the local people and the local Lilydale community, would be pleased to see his former property continue to play a vital part in Lilydale's history.

He believed everything done in business should always make money. He would support the careful residential development of parts of the site to generate the income which will "pay for" for the creation of additional open space – passive and active - for the Lilydale community. This includes the filling of the quarry and the retention of the front oval which was the scene of so many football, cricket and soccer matches by the Cave Hill teams which played in the various local associations. The retention of the oval and surrounds will also ensure future generations will be able to enjoy the 180° vista looking north across Lilydale and the Yarra Valley to the Great Dividing Range.

The site offers a fantastic opportunity for the developer, the shire and the Lilydale community to work in partnership to create the story of the quarry and its operation while creating a unique opportunity to use the historic buildings and kilns to possibly develop a studio precinct for sculptors working in stone, metal or other medium. This has the potential to create a nationally recognised facility which could attract artists from all over the world.
